- a) The T/Shirt is non-compulsory and is available in 5 different styles.

- c) With a collar
- d) The colours are; Yellow with Club Logo and a collar

- e) Hard to set a price, but the fairest way is to charge members the cost of getting the T/Shirt here.
- f) There will be no profit to the Club.
- g) The T/Shirt is 100% synthetic.
- h) The delivery of the T/Shirts is expected to be by mid-April.

John then told members to try on the 3 samples he had brought with him, to gauge size and suitability.

Then fill out a T/Shirt Order Form and pay a deposit of \$10. If we do not reach the goal of 50 sales, the deposit will be refunded. John stated that there must be an order of 50 T/Shirts to make a viable exercise. John would start taking orders immediately after the conclusion of this AGM.
