4 Annual Report

It has been a busy and challenging year but also a very positive one. On all measures, we have regained momentum. Our membership numbers have been steadily increasing. Our finances remain solid as Peter will shortly explain. Details are in the Finance Report (July 2022 - June 2023). Most notably, there has been a pickup in the number of activities and participation rates. The Activity Report (Spring/Sep 2022 - Winter/Aug) 2023) has the details. In summary there were 29 leaders compared with 28 leaders in the same period last year. Overall there were 247 activities, an increase of 45% compared with the previous year, the number of participants increased by 55% to 3064. Thank you to all the leaders who have been so committed and all those participants who have been so enthusiastic. These figures also reveal how much more the leaders have taken on in the last year so – and, as such, are a very clear indication that we need to find ways to encourage more members to make the move into leading some activities.

Russell Verdon stepped down from the Committee in February having spent several years as Publicity Officer. As most of you know, he has now moved to Adelaide to be closer to his family. Julie McDonald stepped into the role in June.

We had a few special events earlier this year: Two 90th birthday lunches – Fred Morrison in February and Pam Robinson in May. Both Fred and Pam have had long and generous associations with club and in many ways laid the groundwork for where we are today.

The issue of insurance for e-bike riders was a challenge we did not expect. Having considered the options, the committee unanimously agreed that members using e-bikes would need to join Bicycle NSW to ensure proper insurance particularly in the case of public liability. While this measure protects individual members, we had to consider how we equip and protect ride leaders as well as the club itself in the longer term. We are in the process of applying for affiliation with Bicycle NSW which will bring with it leader training and protection as well as cover for the club and individual cyclists. It is a big step, but given the increasing popularity of cycling, it is in our best interests to be affiliated with the relevant peak body. We of course continue to be affiliated with Bushwalking NSW,

Our Constitution requires that the President can be in the role for a maximum of two consecutive years, so today I will be stepping down from that role. It has been a privilege. We are all in the Illawarra Ramblers because we enjoy being outdoors, walking, cycling, kayaking and socialising. Several members have been with us for decades, many strong friendships have developed over the years and there is enormous enthusiasm among leaders and participants which makes our club special. Thank you for supporting me and the committee in so many ways.

I would like to thank the committee members who have worked hard to keep our club functioning so well. There is a lot involved and each person on the committee has contributed – Peter Jack (Treasurer) presides over our healthy bank account ensuring good financial management. Penny Lovibond (Secretary) organises our meetings, somehow manages to record our lively discussions and tracks all the incoming and outgoing correspondence. Caroline Hudson (Activities Recorder) keeps records of our activities and participation numbers, chases up tardy leaders and managed to keep across things despite being in WA for a few months. Julie McDonald (Publicity Officer) jumped in enthusiastically, looked at the demographics and targeted parts of the Illawarra where we are not as well represented, to attract new members. Stuart Almond (Program Manager) reviews the activities which are submitted, liaises with the leaders, makes adjustments if necessary and manages to do all of this wherever he is travelling. Colleen Barclay (Training Coordinator), with persistence, has successfully raised awareness of safety issues with regard to cycling, particularly the importance of wearing good quality helmets which are fitted properly. Anne Murdoch (Membership Secretary) keeps track of the memberships and follows up with those who need some reminding about renewing. She also responds to enquiries which is a vital role as it is the first impression a prospective member may have about our club. Pam Hayes (Newsletter Editor) communicates to our members via the newsletter and always manages to find a variety of articles and snippets which make it more interesting. Phil Prentice (Welfare Officer) has a quiet way of keeping in touch with lots of people including those who we may not have seen for a while - a phone call or card lets them know that we are still thinking about them. It's a great team effort, thank you for your contribution and support over the last two years.

An additional thank you to our Public Officer, Fred Morrison. While not a committee position, it is an important role being our contact, as an incorporated entity, with the Department of Fair Trading.

Lastly, thank you to all the people who have helped out today with equipment, catering, setting up, the BBQ, the walks, the raffle and so on. The Rhododendron Garden is a lovely venue, we could not make it happen without your help.

Item 4 - President's Annual Report 13 December 2024

Enhancing the **Rambler's** experience for us all came with improvements in routines as we strived to more clearly present on our website, lift the warmth of our personal welcomes, clarify expectations between leaders and participants as well as highlighting safety first in all that we do.

Beyond the routines there has been a focus on fine tuning the frame of our public profile softly publicising who we are, what we do and that there could be **fun** doing it. The Illawarra Flame, the Kiama Bugle, and even, albeit briefly, ABC Illawarra have shone a light on us. Trips away are quite reportable. Rail Trails Australia and Bicycle NSW have comprehensively reported on our travelling adventures which in turn can attract, and certainly maintain, membership. The current programme features 1 holiday and 2 walking trips including 1 with paddling options.

Training has been another focus. The offer of subsidised first-aid training for our paddlers in February has drawn an amazing response. 18 starters. Something learned along the way is that our paddlers already engage in a self-organised rescue training process, not commonly done with other groups. There will be spillover to our other activities from the Leadership Training the cyclists have undertaken. Our club's e-bike insurance driven leadership accreditation is a standout within the Bicycle NSW cycling community. We are now steadily incorporating learned safety, and courtesy, processes into our activities without noticeably detracting from the friendly way we do things. A big thank-you is warranted for Bicycle NSW Master Ride Leader Werner Steyer, accreditor of 5 of our 11 leaders. Werner is the club's guest at tonight's Xmas Party. Thank you, Werner.

Covered in the quarterly newsletters to members was the news that 2 past leaders, Sue Martin and Life Member Pam Robinson had passed away. A great loss in both cases.

Their passing served to endorse the aspirations of this committee to focus on succession, encouraging and appointing potential future leaders. This is often more easily begun with shared leadership, as on trips. From this you should expect to see continuing experienced, capable people serving on the committee.

Interwoven with our PR public face is our visibility in the community via advocacy. The club does not have a standing role on either Shellharbour or Wollongong Councils. Invitations to comment on Council projects come to us as individuals from time to time where the practice has been to respond as individuals. Our club has the potential to be heard loud and clear on issues which affect us. The **State Upper House Inquiry into e-scooters, e-bikes and other e-mobility devices** was a case affecting walkers and cyclists, our core being, and on which Sam Garrett-Jones prepared an excellent submission. This resulted in the club's attendance at a hearing at State Parliament House. Googling the committee title will lead a reader to see Hansard scripts of the proceedings. Bicycle NSW encourages affiliates like us to have a wish-list of council projects to add purpose and **fun** to our activities. They are running a webinar "**Engaging Your Council.... Now is the best time,"** this coming Monday, 16 December, 7pm. See the Bicycle NSW website or ask a committee member for Zoom details and feel free to attend.

The attached reports tell the year's story. Treasurer Peter is far more eloquent talking about money than I am. He's warming up to speak.

Membership is stable. Events by number of activities, and attendance, are up, and even if you can't be with us, that new measure of the club's health, the fun-<u>o</u>meter, will be getting a real workout at tonight's Xmas celebration.


